## PREAMBLE

The Argentine Secretariat of Sport of the Government of the Argentine Republic and the Department of Sport and Recreation South Africa of the Government of the Republic of South Africa (hereinafter jointly referred to as the "Participants" and separately as a "Participant");

**DESIROUS** to promote friendly relations between the two countries;

**CONSCIOUS** that the Participants appreciate and recognize the expertise, relative strength and competitive advantage that the other has in the particular fields of sport and recreation;

**WILLING** and able to cooperate, exchange knowledge and expertise and assist each other in the fields of sport and recreation;

**AFFIRMING** their commitment to foster and enhance cooperation in the fields of sport and recreation;

**HEREBY** reach the following understanding:

### Paragraph 1 Coordinating Agencies

The coordinating agencies responsible for carrying out the functions under this Arrangement will be the Department of Sport and Recreation South Africa for the Republic of South Africa and the Argentine Secretariat of Sport for the Argentine Republic.

### Paragraph 2 General Responsibilities of Participants

- (1) The Department of Sport and Recreation South Africa will –
    - (a) send a South African U/17 football team to the Argentine Republic to play four matches in November or December 2008. The dates will be finalized by the South African Football Association ("SAFA");
    - (b) offer consultation and exchange of experts in individual sports such as athletics, gymnastics, synchronized swimming and combat sports in the Republic of South Africa; and
    - (c) offer internships in the above sports in the Republic of South Africa.
  
  - (2) The Argentine Secretariat of Sport will –
    - (a) offer consultancy of team sports coaches in soccer, basketball, volleyball and hockey in the Argentine Republic; and
    - (b) offer internships in the above sports in the Argentine Republic.

**Paragraph 3  
Exchange Programmes**

The Participants will facilitate exchange programmes in both countries with regard to recreation and women and sport.

**Paragraph 4  
Delegations**

Technical details with regard to the exchange programmes referred to in Paragraph 3, including the number of individuals and dates, will be determined by the Participants after consultation with the relevant national sports federations of both countries.

**Paragraph 5  
Funding**

The expenses incurred in the implementation of this Arrangement shall be paid by the Participants. The Sending Participant shall bear the international transportation costs and the Host Participant shall pay for meals, accommodation and local transportation costs.


**Paragraph 6  
Amendments**

This Arrangement may be amended at any time by the mutual written consent of the Participants.

**Paragraph 7  
Entry into Effect, Duration and Termination**

- (1) This Arrangement will enter into effect on the date of signature thereof.
- (2) This Arrangement will remain in effect for the period 2008 to 2010, and may be renewed for a further period as may be determined in writing by the Participants, unless terminated by either Participant in writing.
